5.6 Pool Heating

Kym emailed six people regarding the pool temp, got four replies, mostly saying that the pool temp was much the same as previous years. Possibly because the pool blanket was used less than previously due to new staff not comfortable putting the blanket on due to weight and risk with windy conditions, the heat was not always retained for the early morning swimmers.

5.7 St John Defibrillator

The Darkan Primary School P&C received a grant for purchasing a defibrillator through St Johns. The equipment has been paid for, we are waiting for a date to do a site inspection and finalise location. It requires 24hr access, so we are suggesting close to the entry signs/gate. Training and signage is also included.

5.8 Last Four Weeks of Season

(Between 5 April and 3 May) Pool Usage (Season Closing Date - 3 May 2019) The pool was closed on 3 May 2019. A minimum of four hours labour plus chemical is required to keep the pool open each day.

Junior Swim Club run by Tanya Thaw operated weekly during Feb-April with last date being 9 April 2019. Baby swim finishes end of March.
