CONDITIONS OF STAY

Thank you for visiting. We hope you have a pleasant and safe stay and decide to return in the future. Please help us keep the facilities clean and useful for all park patrons and observe the following conditions of stay:

- 1. Payments for bookings online at the caravan park and chalets must be made 24 hours prior to your stay.
- 2. Changes to booking dates will be made where possible without a fee.
- 3. All booking cancellations received with less than 24 hours' notice will incur a fee of one night's accommodation.
- 4. One carpark is allocated per Site/Cabin.
- 5. A maximum 28 consecutive day stay in any three-month period applies in accordance with the Caravan and Camping Grounds Act 1995 (WA) and Clause 5A Schedule 7 Caravan Parks and Camping Grounds Regulations 1997. All occupiers are bound by the regulations.
- 6. You may retain the ablutions key and any codes provided for the facilities for the term of your stay but return any key before leaving; no codes are to be used beyond the period you have paid for.
- 7. Guests are responsible for their visitor's behaviour. In the interest of all guests enjoying their stay we ask that excessive noise is ceased between 10pm and 7am. Music & TVs should not be audible to adjoining sites.
- 8. Parents are responsible for ensuring their children do not disturb the peace and quiet of other park guests.
- 9. Dogs are to be always kept on a leash and owners (occupiers) are responsible for cleaning up after their dog. Bags are supplied near the gas bottles at the ablutions block place bags in rubbish bins provided.
- 10. Under the Caravan Parks & Camping Grounds Act (1995) & Regulations (1997), pets are NOT allowed in onsite park accommodation or facilities at any time.
- 11. Pets must not be left alone, onsite, at any time during your stay.
- 12. Maximum of 2 dogs per site.
- 13. Animal bedding and other pet materials are not to be washed in the bathrooms or washing machines the laundry trough can be used but must be cleaned afterwards.
- 14. No smoking is permitted in any areas such as the accommodation, ablutions, kitchen, or laundry.
- 15. Please keep your site clean and tidy and use the facilities provided for drying your clothes and rubbish disposal. Do not remove any waste from the bins. This includes recyclable materials.
- 16. Please remove all belongings from the ablutions and mop the floors after use.
- 17. Please leave the kitchen area tidy for other users. Wipe all surfaces, wash, and put away dishes, and sweep the floor.
- 18. Barbeque is to be left clean after each use so the next camper can enjoy their meal.
- 19. The dump point is provided for caravan park users only and should be cleaned and re-locked after each use.
- 20. Council reserves the right to evict any person who fails to obey the park rules. Eviction from the park will result in forfeiture of all monies paid.
- 21. Fires are prohibited in the fire pit between the months of August-April (season dependent).
