LIABILITY

The owners and its servants and agents accept no responsibility for the theft or damage to any property brought onto the Darkan Caravan Park by any person. Acceptance of the following conditions is implied by your choosing to stay within the Park.

CONDITIONS OF STAY

- 1. Payments for bookings online at the caravan park and chalets must be made 24 hours prior to your stay.
- 2. Changes to booking dates will be made where possible without a fee.
- 3. Booking cancellations received with less than 24 hours' notice will incur a one-night accommodation fee.
- 4. Check—in Time is from 2:00 p.m.; check—out time is strictly 10 a.m. unless prior arrangements have been made with management.
- 5. One carpark is allocated per Site/Cabin.
- 6. A Speed Limit of 8 km/hour strictly applies.
- 7. Washing of vehicles is not permitted.
- 8. A maximum 28 consecutive-day stay in any three-month period applies. All occupiers are bound by this condition.
- 9. You may use the ablutions codes provided for the facilities for your stay; no codes are to be used beyond the period you have paid for.
- 10. Guests are responsible for their visitors' behaviour. In the interest of all guests enjoying their stay, we ask that excessive noise be ceased between 10 pm and 7 am. Music and TVs should not be audible to adjoining sites.
- 11. Anti-social behaviour, indecent behaviour and the use of illegal substances will not be tolerated at any time and can result in the Police being called and you being asked to leave the property immediately.
- 12. Parents are responsible for ensuring their children do not disturb the peace and quiet of other park guests.
- 13. Dogs must always be kept on a leash, and owners (occupiers) are responsible for cleaning up after their dogs. Bags are supplied near the gas bottles at the ablutions block—place bags in the rubbish bins provided.
- 14. Under the Caravan Parks & Camping Grounds Act (1995) and Regulations (1997), pets are NOT allowed in on-site park accommodation or facilities at any time.
- 15. Pets must not be left alone, onsite, at any time during your stay.
- 16. Maximum of 2 dogs per site.
- 17. Animal bedding and other pet materials are not to be washed in the bathrooms or washing machines—they can be washed in the laundry trough, but it must be cleaned afterwards.
- 18. Smoking is not permitted in any areas, such as the accommodation, ablutions, kitchen, or laundry.
- 19. Please keep your site clean and tidy and use the facilities provided for drying your clothes and rubbish disposal. Do not remove any waste from the bins. This includes recyclable materials.
- 20. Please remove all belongings from the ablutions and mop the floors after use.
