Re: HA & SJ Harries Kennel License application.

We wish to apply for a 20 dog kennel license, to be kept at 3497 Boyup Brook/Arthur Rd, Trigwell, for our own livestock working dogs. We at times have upto 20 working border collies and wish to have a licence for this. These dogs are used daily for our own and contract sheep and cattle work as well as competition dog trials on weekends. We are a family of 4 and all have our own dogs and for our work and competition. We like to breed the occasional litter 1-2 per year and sometime prefer to keep them until they are showing their potential on sheep before we sell any surplus.

The current kennels we are using and would like to continue to use are pre made and come flat packed, we then put together, they are in bays of 1-3 pens and are a steel frame with Colourbond rear enclosure. They are on skids and easily movable (they are 'not permanent fixtures) They are raised 600mm off the ground,(we will not have our dogs on the ground due to snakes or concrete due to causing arthritis) Each bay is 2100mm long x 950mm wide x 970 mm high (as per appendix 1: health and welfare of dogs in Western Australia. For working livestock dogs). It is 1 dog per bay and has a fibreglass composite floor. They have a kennel in the back and straw as bedding. With a 9Ltr stainless steel water bucket. The area where the kennels are located is a 0.7ac fenced area where they are let out minimum of 2 times per day no less than 1 hour each time if they are home and not at work or a trial.

The nearest dwelling that is not on our property is 3636 Boyup Brook/Arthur Rd and is 1.36km from where the kennel location is.










SIDE ELEVATION
